

Wilson –“Win a VIP trip to the US Open – Consumer Sweepstakes”

Official Rules 01/30/2009

THE FOLLOWING SWEEPSTAKES IS INTENDED FOR PLAY IN THE UNITED STATES ONLY AND SHALL ONLY BE CONSTRUED AND EVALUATED ACCORDING TO U.S. LAW. DO NOT ENTER THIS SWEEPSTAKES IF YOU ARE NOT LOCATED IN THE U.S. AT TIME OF ENTRY.

NO PURCHASE NECESSARY TO ENTER OR WIN PRIZE. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

1) ELIGIBILITY: This Sweepstakes is offered only to legal residents of the 50 United States and the District of Columbia with a valid mailing address (P.O. Box not accepted) (“United States”), 21 years of age and older as of January 1, 2009. Employees of Wilson Sporting Goods Co. (“Sponsor”), United States Tennis Association (“USTA”), their respective parent, affiliates, subsidiaries and related companies, advertising and promotion agencies, and the immediate families (spouse, and parents, siblings and children, and each of their respective spouses regardless of residence) and household members of each, whether related or not, are not eligible. Bryn Mawr Ave., Chicago, IL 60631 (postmarked no later than July 31, 2009) and received by August 6, 2009. Both methods of entry have the same chance of winning. All entries become the property of the Sponsor and will not be returned.

Limit one (1) entry per person, per household, per email address, regardless of method.

1) PRIZES: One (1) Grand Prize: Trip consists of round trip airfare for two persons to New York City, NY, three (3) nights hotel accommodations (based upon standard double occupancy), round trip airport to hotel transportation, two (2) tickets to the Day and Night Session of the US Open on Monday, August 24, 2009, VIP admission for two into the Wilson Players Party on Saturday, August 22, 2009, Admission for two to the US Open Qualifying Round on Sunday, August 23, 2009. Approximate Retail Value: \$2,500.

4) PRIZE RESTRICTIONS/CONDITIONS: All Prizes are non-transferable. No cash redemption or other prize substitution except by Sponsor, in their sole discretion if featured prize becomes unavailable.
