

THE 2016 WILSON PRO STAFF GIVEAWAY
(the "Giveaway")

OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. ENTRY IN THIS GIVEAWAY CONSTITUTES YOUR ACCEPTANCE OF THESE OFFICIAL RULES. EACH PRIZE WINNER IS ONLY ELIGIBLE TO WIN ONE PRIZE IN THE GIVEAWAY.

Sponsors: Wilson Sporting Goods Co., a Delaware corporation, with a principal office at 8750 W. Bryn Mawr Ave., Chicago, IL 60631 ("Sponsor").

1. Eligibility:

You must be 13 years or older and a legal resident of any of the 50 United States or the District of Columbia (the "Territory"). Void where prohibited or restricted by law. Void in overseas U.S. territories, possessions, commonwealths and military installations, and where prohibited or restricted by law. (a) The Giveaway begins at 12:00:00 AM Central Standard Time (GMT -6) on Wednesday, August 3, 2016 and ends at 1:59:59 PM Central Daylight Time (GMT -6) ("CDT") on Friday, August 26, 2016 (the "Promotional Period"). Entries must be received by Sponsor by 1:59:59 PM CDT on Friday, August 26, 2016.

(b) To enter, during the Promotion Period, visit the Wilson Pro Staff Giveaway Website [wilson.com/fromfederer] (the "Website") to complete an entry form. The only valid way to enter the Giveaway is by completing an entry form on the Website. Incomplete or inaccurate entry forms are void. Follow the instructions to complete the Giveaway entry form, including submitting your name, address, email address and other required information. By entering, you acknowledge compliance with these Official Rules including all eligibility requirements.

(c) Prizes will only be awarded from eligible entry forms. A maximum of one (1) Prize will be selected at random each week during the Promotional Period from a drawing of all eligible entries, for a total of four (4) Prizes during the Promotional Period.
