OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. ENTRY IN THIS SWEEPSTAKES CONSTITUTES YOUR ACCEPTANCE OF THESE OFFICIAL RULES. EACH PRIZE WINNER IS ONLY ELIGIBLE TO WIN ONE PRIZE IN THE SWEEPSTAKES.

Sponsor: Wilson Sporting Goods Co., a Delaware corporation, with a principal office at 1 Prudential Plaza, 130 E. Randolph Street, Suite 600, Chicago, IL 60601 ("Sponsor").

THIS SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED, OR ADMINISTERED BY, OR ASSOCIATED WITH INSTAGRAM.

**1. Eligibility:** The Sweepstakes is open only to permanent, legal residents of (i) the fifty (50) United States and the District of Columbia (excluding, however, the states of Florida, New York, and Rhode Island), (ii) Canada (excluding, however, the Province of Quebec), and (iii) the United Kingdom who are at least 13 years of age or older at the time of entry and have internet access as of February 5, 2018. Employees of Wilson Sporting Goods Co. and any of its respective related companies, parents, subsidiaries, affiliates, and agents and any agencies or other companies involved in the development or execution of the Sweepstakes or production or distribution of Sweepstakes materials, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

**2. Agreement to Official Rules:** By participating in the Sweepstakes, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Sponsor which are final and binding in all matters related to the Sweepstakes.

**3. Timing:** The Sweepstakes begins on February 6, 2018 at 12:00:00 p.m. Central Time (U.S.) ("CT") and ends on February 11, 2018 at 11:59:59 p.m. CT (the "Promotion Period"). Sponsor's computer is the official time-keeping device for the Sweepstakes.

**4. How to Enter:** There are two methods of entry:

- (i) *Instagram Entry:* during the Promotion Period, log into Instagram, visit the Wilson Tennis Instagram account, @Wilsontennis, and like and comment on the post announcing the Roger Federer Commemorative Pro Staff RF20 Giveaway, including the hashtag #RF20Giveaway. If you do not already have an Instagram account, you can visit [www.instagram.com](http://www.instagram.com) to create one for free; or,
- (ii) *Postcard Entry:* during the Promotion Period, write your name, home address, date of birth, phone number, and valid email address on a 3" x 5" card and mail to "Roger Federer Commemorative Pro Staff RF97", Attn: Racquet Sports Division, 1 Prudential

Plaza, 130 E. Randolph Street, Chicago, IL 60601. Postcard Entries must be postmarked by February 11, 2018 and received by February 18, 2018.

All methods of entry have the same chance of winning. All entries become the property of the Sponsor and will not be returned.

**ONLY ONE ENTRY BY ANY ELIGIBLE ENTRANT WILL BE ELIGIBLE TO WIN A PRIZE. ANY ADDITIONAL ENTRIES BY A USER WILL BE DISQUALIFIED.**

Entries cannot contain trademarks, logos or trade dress owned by others (except Wilson), or advertise or promote any brand or product of any kind including, but not limited to brand names or logos. If you post updates to or receive updates from Instagram via SMS from your wireless phone, your wireless service provider may charge you for each text message you send and receive. Please consult your wireless service provider for more information. All terms and conditions of Instagram.com apply. Multiple entrants are not permitted to share the same Instagram account. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different Instagram accounts, identities, registrations, or logins, or through any other methods, may void all of that entrant's entries and that entrant may be disqualified. **5. Winner Determination:** Sponsor will randomly select the potential winner from all eligible entries received during the Promotion Period, on or around February 19, 2018. The drawing will take place at the Sponsor's offices at the address set forth above. The potential prize

winner will be notified by Private Message on Instagram or via email for the Postcard Entries. Except where prohibited, the potential prize winner will be required to sign and return a Winner Declaration & Consent, which must be received by Sponsor, within 10 days of the date notice or attempted notice is sent, in order to claim his/her prize. If any potential prize winner is a Canadian resident he/she will be required to answer a time limited skill testing question without assistance of any kind whether mechanical or otherwise, in order to be eligible to receive a prize. **One (1) Prize** – The Prize will each consist of one (1) Commemorative Pro Staff RF97 tennis racquet autographed by Roger Federer. Approximate Retail Value of Prize: \$20,006.00 USD / \$24,850 CAD / £14,168 GBP.

The following applies to the Prize: except as specifically provided herein, the Prize does not include taxes, or any other item not specifically described in these Official Rules, and all expenses for any of the foregoing are the sole responsibility of the Prize Winner. The Prize Winner may be issued an IRS 1099 form. The Prizes may not be transferred or assigned except by Sponsor. No substitutions, cash equivalents or redemptions of prize will be made. If Prize, or any portion thereof, cannot be awarded for any reason, Sponsor reserves the right to substitute prizes with other prizes of equal or greater value. Reporting and payment of all applicable taxes, fees, and/or surcharges, if any, arising out of, or resulting from, acceptance or use of a prize, are the sole responsibility of the Prize Winner.
