

**Wilson “Driver vs. Driver VIP Sweepstakes”**  
**(The “Sweepstakes”)**  
**Official Rules**

THE FOLLOWING SWEEPSTAKES IS INTENDED FOR PLAY IN THE UNITED STATES AND CANADA (EXCLUDING THE PROVINCE OF QUEBEC) ONLY AND SHALL ONLY BE CONSTRUED AND EVALUATED ACCORDING TO U.S. LAW. DO NOT ENTER THIS SWEEPSTAKES IF YOU ARE NOT LOCATED IN THE U.S. OR CANADA (EXCLUDING QUEBEC) AT TIME OF ENTRY.

**NO PURCHASE NECESSARY TO ENTER OR WIN PRIZE PACKAGE. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ODDS OF WINNING DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED.**

**1) ELIGIBILITY:** This Sweepstakes is offered only to legal residents of the 50 United States and the District of Columbia and Canada (excluding, the Province of Quebec) with a valid mailing address (P.O. Box not accepted), eighteen (18) years of age and older as of October 30, 2018. Employees of Wilson Sporting Goods Co. (“Sponsor”), its parents, affiliates, subsidiaries and related companies, advertising and promotion agencies, and the immediate families (spouse, and parents, siblings and children, and each of their respective spouses regardless of residence) and household members of each, whether related or not, are not eligible. Void where prohibited.

**2) HOW TO ENTER:** No purchase necessary. Sweepstakes begins at 9:00:00 a.m. Central Time (“CT”) on October 30, 2018 and ends at 11:59:59 p.m. CT on December 7, 2018 (the “Entry Period”). During the Entry Period, visit [www.wilson.com/DVDSweeps](http://www.wilson.com/DVDSweeps) to complete an entry form including submitting your name, address, email address, and other required information. BY SUBMITTING AN ENTRY, ENTRANT ACKNOWLEDGES THAT HIS/HER NAME MAY BE POSTED ON THE WILSON FAN PAGES OR ON OTHER SPONSOR WEBSITES, IN SPONSOR’S DISCRETION IN CONNECTION WITH THE SWEEPSTAKES.

**3) PRIZE: LIMIT ONE (1) ENTRY PER PERSON, PER HOUSHOLD, PER E-MAIL ADDRESS.** One (1) Prize Package per Person. Prize Package consists of round trip airfare for two (2) persons from a major commercial airport near the Prize Winner’s home to Orlando, Florida, hotel accommodations for up to two (2) nights (based upon standard double occupancy) in Orlando, Florida, standard rental car accommodations for up to three (3) days, two (2) custom driver fittings at Club Champion for the winning driver from *Driver vs. Driver 2*, one (1) round of golf for two (2) persons, and two (2) tickets for a behind the scenes tour of Golf Channel headquarters.
