# WILSON.COM AUTOGRAPHED BLADE SWEEPSTAKES Official Rules

Official Rules for Participating in the WILSON.COM AUTOGRAPHED BLADE SWEEPSTAKES ("Terms")

#### 1. General Terms

By participating in the Wilson.com Autographed Blade Sweepstakes (the "Promotion"), you accept these Terms. Please read these Terms carefully before participating. If you do not agree to the Terms, you may not participate in the Promotion.

These Terms govern the relationship between you ("you" or the "Participant") and Wilson Sporting Goods Co., 130 East Randolph Street, Suite 600, Chicago, Illinois 60601 USA; email: <a href="mailto:consumerservice-us-en@wilson.com">consumerservice-us-en@wilson.com</a> ("Organizer") in relation to the Promotion. Questions and feedback about the Promotion may be brought to the attention of Organizer through the aforementioned contact details. The Promotion begins on August 16, 2021 at 12:00:00 am Central Time, United States ("CT") and ends on August 31, 2021 at 11:59:59 pm CT (inclusive) ("Promotion Period"). Only entries received within the Promotion Period will be taken into account.

The Promotion promotes Wilson Sporting Goods Co.

## 2. Right to Participate

The Promotion is open to individuals who are legal residents of the fifty (50) United States and the District of Columbia (the "Territory") who (i) reside and are physically located in the Territory and (ii) have reached the age of majority in the place of their residency at the time of entry. The Organizer may require a winner to certify their eligibility to participate in the Promotion.

Employees, officers, directors, representatives and agents of the Organizer or those of any of its affiliates, as well as the immediate family (defined as parents, siblings, children and spouses, regardless of where they live) or households (whether or not related) of such employees, officers, directors, representatives and agents and anyone otherwise connected with the operation or fulfillment of the Promotion, are not eligible to participate in the Promotion. ## 3. Instructions for Participation

By entering the Sweepstakes, you agree to comply with and be bound by these Terms. Once you have completed the entry form, you will receive one entry to the Promotion.

Failure to comply with the Official Rules may result in disqualification from the Sweepstakes. <u>Limit</u>: Up to one (1) entry per person during the Promotion Period. Multiple participants are not permitted to share the same email address. No responsibility is accepted for late, lost, delayed, damaged, corrupted, illegible or incomplete entry forms, which shall be disqualified at the discretion of the Organizer, or for transmission or computer error affecting the logging of entry forms. Proof of posting will not be accepted as proof of delivery.

## 4. Selection of Winner

Up to six (6) potential Prize Winners will be randomly selected from a drawing of all eligible entries received during the Promotion Period in compliance with these Terms. The First Prize (defined below) Winner will be the first Prize Winner drawn, the Second Prize (defined below) Winner will be the second Prize Winner drawn, the Third Prize (defined below) Winner will be the third Prize Winner drawn, the Fourth Prize (defined below) Winner will be the fourth Prize Winner drawn, the Fifth Prize (defined below) Winner will be the sixth Prize Winner drawn. IF LESS THAN SIX (6) ELIGIBLE ENTRIES ARE SUBMITTED IN COMPLIANCE WITH THESE TERMS DURING THE PROMOTION PERIOD, THEN LESS THAN SIX (6) PRIZES WILL BE AWARDED. IF NO ELIGIBLE ENTRIES ARE SUBMITTED IN COMPLIANCE WITH THESE TERMS DURING THE PROMOTION PERIOD, THEN NO PRIZES WILL BE AWARDED. Prizes will be shipped out to the verified winner's address within 6-8 weeks of the end of the Promotion.

The names of the winners may also be published on the Sweepstakes website and on Organizer's social media channels to the extent a winner has not prohibited the publication of their name. By entering this Promotion, you agree to such publication of your name if you are a winner. You are allowed to withdraw your consent at any time. If a winner cannot be reached within seven (7) business days as of the date on which the Organizer first attempted to reach the winner, or if the Organizer has reasonable grounds for believing that a Participant has contravened any of these Terms, the initial winner will be considered to have forfeited their right to the prize and the Organizer is entitled to either select another winner or forego awarding the Prize. Features of each Prize, including but not limited to the color, size, specifications, shall be determined by Organizer at its sole discretion.

The Prize is personal, non-exchangeable, non-transferable and non-refundable. No cash alternative is available, except if a prize (or any part thereof) becomes unavailable due to circumstances beyond the

Each Participant will not knowingly damage or cause interruption to the Promotion and/or prevent others from participating in the process. CAUTION: ANY ATTEMPT TO DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF THE PROMOTION HEREUNDER VIOLATES CRIMINAL OR CIVIL LAWS. Subject to previous section, the following shall apply. To the extent permitted by applicable mandatory law, by participating in the Promotion, you agree to release the Organizer and its parents, affiliates, subsidiaries, and related companies, divisions, advertising and promotion agencies and the respective employees, directors, and officers of the foregoing "collectively, the "Releasees") from any and all liability arising in any manner out of the Promotion including, without limitation, the selection of the winner, the administration of the Promotion, and the acceptance or the use of the prize or any component thereof as well as to indemnify and hold the Releasees harmless from and against any claims, damages, liabilities, losses, costs or expenses arising from, or attributable to, any of your acts or omissions relating to the Promotion. Except in the event of gross negligence or willful misconduct, the Releasees' liability will in any case be limited to the value of the prize to the extent permitted by applicable mandatory law.

## 8. Dispute Resolution

This Promotion is offered only in the fifty (50) United States and the District of Columbia.

All claims must be resolved in the federal or state courts of Cook County, Illinois, United States.
