(the “Sweepstakes”)
OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. ODDS OF WINNING DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED.

Sponsor: Wilson Sporting Goods Co., a Delaware corporation, with a principal office at 130. E. Randolph St. Ste. 600. Chicago, IL 60601 and its respective parents, affiliates and subsidiaries, and the directors, officers, employees, and agents (“Sponsor”).

1) ELIGIBILITY: This Sweepstakes is offered only to permanent, legal residents of the fifty (50) United States and the District of Columbia (excluding Puerto Rico, the U.S. Virgin Islands and U.S. Military installations in foreign countries), with a valid mailing address (P.O. Box not accepted) (“United States”), who (i) are between fourteen (14) years of age and twenty two (22) years of age as of the day on which they enter, and (ii) are a member of a high school or college basketball team. Employees of Sponsors, and of each of their respective parents, affiliates, subsidiaries and related companies, advertising and promotion agencies, and the immediate families (spouse, and parents, siblings and children, and each of their respective spouses regardless of residence) and household members of each, whether related or not, are not eligible. Void where prohibited.

2) TIMING: The Sweepstakes begins at 12:00:00 AM Central Time (“CT”) on January 24, 2024 and ends at 11:59:59 PM CT on February 2, 2024 (the “Entry Period”).

3) HOW TO ENTER: No purchase necessary. **Entry:** During the Entry Period, entrants must visit the designated Wilson webpage and complete an entry form for entry into the Sweepstakes. The only valid way to enter the Sweepstakes is by completing an entry form on the designated Wilson website. Incomplete or inaccurate entry forms are void. Follow the instructions on the webpage to complete the Sweepstakes entry form, including submitting your name, email address, and other required information. By entering, you acknowledge compliance with these Official Rules including all eligibility requirements. Failure to comply with the Official Rules may result in disqualification from the Sweepstakes. Entries become the property of Sponsors and will not be returned. BY SUBMITTING AN ENTRY, ENTRANT ACKNOWLEDGES THAT HIS/HER NAME MAY BE POSTED ON ANY SPONSORS MEDIA PAGES OR ON SPONSORS WEBSITES, IN SPONSOR’S DISCRETION IN CONNECTION WITH THE SWEEPSTAKES.

LIMIT ONE (1) ENTRY PER PERSON, PER EMAIL ADDRESS, OR PER HOUSEHOLD ADDRESS DURING THE PROMOTIONAL PERIOD. LIMIT OF ONE (1) PRIZE PER PERSON FOR THIS PROMOTION. Although subsequent attempts to enter may be received, only the first entry received from a particular individual will be eligible to win. Additional attempts to enter the same drawing will be disqualified. The submission of an entry is solely the responsibility

of the entrant. Entries may only be made according to the method described above. Only eligible entries actually received by Sponsors and Administrators before the end of the specified entry deadline will be included in the prize drawing. Illegible, unintelligible, incomplete or garbled entries will be disqualified.

4) CONDUCT: By entering the Sweepstakes, entrants agree to comply with and be bound by these Official Rules. The Official Rules will be available throughout the Entry Period on the Wilson website. Failure to comply with these Official Rules may result in disqualification from the Sweepstakes.

Sponsor reserves the right at its sole discretion to disqualify any individual it finds to be: (a) tampering or attempting to tamper with the entry process or the operation of the Sweepstakes; (b) violating the Official Rules; or (c) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. 5) PRIZES. LIMIT ONE (1) PRIZE PER PERSON: ONE (1) Prize; one (1) Prize per person.

The “Prize”: The Prize consists of (i) one (1) training session with Chris Brickley (Approximate Retail Value (“ARV”): \$250) (ii) travel accommodations from the Prize Winner’s principal place of residence to the training location decided in Sponsor’s sole discretion, (which may but is not required to include round-trip airfare for up to two (2) people from a major commercial airport near the Prize Winner’s principal place of residence or the fee for a rental car to take up to two (2) people from Prize Winner’s principal Place of residence to the training location, and one (1) nights’ hotel accommodations (based upon standard double occupancy) in the city of Sponsor’s decided training location (ARV: \$400); (iii) Three (3) Chris Brickley training basketballs (ARV: \$150); and (iv) One (1) Wilson outfit, determined by Wilson in Wilson’s sole discretion (ARV: \$200).

Approximate Retail Value (“ARV”) of the total Prize: \$1,000 USD.

Specific date of the training shall be determined by Sponsor in its sole discretion.

Actual value of trip may vary based on point of departure and airfare fluctuations. Any difference between stated approximate retail value and actual value of Prize will not be awarded. No alternative travel dates are available. Exact travel dates and arrangements subject to availability. If winner is eligible, but is a minor in his/her jurisdiction of residence, winner must be accompanied by winner’s parent or legal guardian (“Travel Guest”) . Winner and Travel Guest must travel on same itinerary. Minors must be accompanied at all times during the trip (including, but not limited to, in-flight, hotel stay and all prize-related events) by Travel Guest.

6) PRIZE RESTRICTIONS/CONDITIONS: The Prizes are non-transferable. No cash redemption or other prize substitution except by Sponsor, in its sole discretion if featured Prize items become unavailable. Any difference between stated ARV and actual value of Prizes will not

be awarded. Prize Winners are responsible for all taxes on the Prizes. Sponsor may issue an IRSS Form 1099-MISC for Prize Winners. ARV is as of the time these Official Rules were printed and the value of the Prizes may fluctuate. A winner is not entitled to any difference between the ARV and the actual value of the Prize at the time the Prize is awarded. Meals, gratuities, luggage fees, incidental hotel charges and any other travel-related expenses not specified herein are the sole responsibility of Prize Winner. Prize Winner and guest must have all necessary identification and/or travel documents (e.g., a valid U.S. driver's license or government issued passport) required for travel and must not have any barrier to entry in the United States.

7) DRAWING: One (1) potential Prize Winner will be selected at random from a drawing of all eligible entries received during the Entry Period. The date of the selections will be on or about 11:00:00 AM CT on February 6, 2024.

The odds of winning will depend on the total number of eligible entries during the Entry Period.

8) NOTIFICATION OF WINNERS/AWARDING OF PRIZE: The potential Prize Winners will be notified via email and may be publicly announced on Sponsor media pages. A Prize Winner shall have twenty four (24) hours to respond, and may be required to complete, sign, have notarized and return an Affidavit of Eligibility and Liability Release and, where legal, a Publicity Release within time specified on the prize notification or the Prize may be forfeited and awarded to an alternate winner. If a potential Prize Winner does not respond within twenty four (24) hours of notification, if documents are not timely returned, or if a prize notification is returned as undeliverable, the Prize may be forfeited and awarded to an alternate winner, even if another potential Prize Winner has already been announced.

Any use of robotic, automatic, programmed or similar entry methods will void all such entries by such methods.
