

WILSON SUMMER OF SPORT GIVEAWAY
(the “Sweepstakes”)
Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN PRIZE. A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING. ODDS OF WINNING DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED.

SPONSOR: Wilson Sporting Goods Co., 130 East Randolph Street, Suite 600, Chicago, Illinois 60601, United States of America, and its respective parents, affiliates and subsidiaries, and the directors, officers, employees, and agents of each (“Sponsor”).

1) ELIGIBILITY: This Sweepstakes is offered only to permanent, legal residents of the fifty (50) United States and the District of Columbia (excluding Puerto Rico, the U.S. Virgin Islands and U.S. Military installations in foreign countries), with a valid mailing address (P.O. Box not accepted) (“United States”), of at least eighteen (18) years of age or older as of the day on which they enter. Employees of Sponsor, and of each of their respective parents, affiliates, subsidiaries and related companies, advertising and promotion agencies, and the immediate families (spouse, and parents, siblings and children, and each of their respective spouses regardless of residence) and household members of each, whether related or not, are not eligible. Void where prohibited.

2) TIMING: The Sweepstakes begins at 08:00:00 a.m. Central Standard Time (“CST”) on Thursday, August 11, 2022, and ends at 11:59:59 p.m. CST on Friday, September 16, 2022 (the “Entry Period”).

3) HOW TO ENTER: No purchase necessary. **Entry:** During the Entry Period, entrants must visit the designated Sponsor webpage [URL] and complete an entry form for entry into the Sweepstakes. The only valid way to enter the Sweepstakes is by completing an entry form on the designated Sponsor website. Incomplete or inaccurate entry forms are void. Follow the instructions on the webpage to complete the Sweepstakes entry form, including submitting your name, email address, and other required information. By entering, you acknowledge compliance with these Official Rules including all eligibility requirements. Failure to comply with the Official Rules may result in disqualification from the Sweepstakes. Entries become the property of Sponsor and will not be returned. 4) LIMIT ONE (1) ENTRY PER PERSON. No other entry methods or forms of entry are valid. Participants may not use any device or artifice to register more than one time or as multiple registrants. Any eligible entrant who attempts to enter with multiple email addresses and/or phone numbers under multiple identities or uses any device or artifice to enter more than one time will be disqualified and forfeits any and all prizes won, at Sponsor’s discretion.

5) PRIZES. LIMIT ONE (1) PRIZE PER PERSON: Up to One (1) Prize; one (1) Prize per person.

The “Prize”: The “Prize” consists of one (1) Wilson Sportswear Outfit Pack, and one (1) Wilson Equipment Prize Pack. Approximate Retail Value (“ARV”) of the Prize: \$434 USD. The Wilson Sportswear Outfit Pack consists of one (1) bottom (ARV: \$58 USD); one (1) top (t-shirts, polos, bramis, or tanks) (ARV: \$48); and one (1) jacket or outerwear item (ARV: \$68 USD). Clothing will be selected by the Winner from

Sponsor provided options. The Wilson Equipment Prize Pack consists of the Winner's choice of either one (1) Pickleball Package; one (1) Basketball Package; one (1) Golf Package; one (1) Volleyball Package; one (1) Football Package; one (1) Tennis Package; or one (1) Baseball/Softball Package. The Pickleball Package contains one (1) pickleball paddle (ARV: \$119.95) and one (1) two pack of pickleball balls (ARV: \$6.49). The Basketball Package consists of one (1) WNBA or NBA Authentic Indoor/Outdoor Basketball (ARV: \$49.95) and one (1) WNBA or NBA Authentic Backpack (ARV: \$49.95). The Golf Package includes one (1) dozen Triad Golf Balls (ARV: \$29.99); one (1) Staff Model Golf Glove (ARV: \$23.99); one (1) hat (ARV: \$34.00); and one (1) visor (ARV: \$34.00). The Volleyball Package consists of one (1) AVP Optx Game Ball (ARV: \$79.95) and one (1) AVP Beach Volleyball Backpack (ARV: \$69.99). The Football Package consists of one (1) NFL The Duke Replica Football (ARV: \$45.95) and one (1) Wilson Traveler Backpack (ARV: \$78.00). The Tennis Package consists of one (1) performance racquet (Pro Staff, Blade, Ultra, or Clash) (ARV: \$149.00) and one (1) Trinita 3-ball Sleeve (ARV: \$7.49). The Baseball/Softball Package consists of one (1) A1000 Baseball Glove (ARV: \$149.95) and one (1) A2000 Backpack (ARV: \$109.95). Winner may select only one Package, and will not be permitted to mix and match Package items. Equipment will be selected by the Winner from Sponsor provided options, when applicable.

6) PRIZE RESTRICTIONS/CONDITIONS: The Prizes are non-transferable. No cash redemption or other prize substitution except by Sponsor, in its sole discretion if featured Prize items become unavailable. Any difference between stated ARV and actual value of Prizes will not be awarded. Prize Winners are responsible for all taxes on the Prizes. Sponsor may issue an IRSS Form 1099-MISC for Prize Winners. ARV is as of the time these Official Rules were printed and the value of the Prizes may fluctuate. A winner is not entitled to any difference between the ARV and the actual value of the Prize at the time the Prize is awarded.

7) DRAWING: Up to one (1) potential Prize Winner will be selected at random from a drawing of all eligible entries received during the Entry Period. The date of the selections will be on or about 11:00:00 AM CST on Monday, September 19, 2022. The odds of winning will depend on the total number of eligible entries during the Entry Period.

8) NOTIFICATION OF WINNERS/AWARDING OF PRIZE: The potential Prize Winners will be notified via email, telephone, or social media message and may be publicly announced on Sponsor media pages. A Prize Winner shall have (3) days to respond, and may be required to complete, sign, have notarized and return an Affidavit of Eligibility and Liability Release and, where legal, a Publicity Release within time specified on the prize notification or the Prize may be forfeited and awarded to an alternate winner. If a potential Prize Winner does not respond within three (3) days of notification, if documents are not timely returned, or if a prize notification is returned as undeliverable, the Prize may be forfeited and awarded to an alternate winner, even if another potential Prize Winner has already been announced.
