## Wilson "2018 DUO Soft" Sweepstakes Official Rules

THE FOLLOWING SWEEPSTAKES IS INTENDED FOR PLAY IN THE UNITED STATES AND CANADA (EXCLUDING THE PROVINCE OF QUEBEC) ONLY AND SHALL ONLY BE CONSTRUED AND EVALUATED ACCORDING TO U.S. LAW. DO NOT ENTER THIS SWEEPSTAKES IF YOU ARE NOT LOCATED IN THE U.S. OR CANADA AT TIME OF ENTRY.

NO PURCHASE NECESSARY TO ENTER OR WIN PRIZE. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ODDS OF WINNING DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED.

- 1) **ELIGIBILITY**: This Sweepstakes is offered only to legal residents of the 50 United States and the District of Columbia and Canada (excluding, the Province of Quebec) with a valid mailing address (P.O. Box not accepted), 18 years of age and older as of November 6, 2017. Employees of Wilson Sporting Goods Co. In-Store Appointment Method: During the Entry Period, visit a participating Wilson Staff authorized dealer location and complete a Wilson Staff club-fitting. Then, following your club-fitting and during the Entry Period, visit http://www.wilson.com/DUOSoftSweeps to complete an entry form including submitting your name, address, email address, verification of club-fitting and other required information. Entrants must attend a designated club-fitting to be eligible to win a Prize in the Sweepstakes under either the Online Appointment or In-Store Appointment methods of entry. All Online Appointment and In-Store Appointment entries must be received by 11:59:59 p.m. CT on March 4, 2018. Write-in Entry must be postmarked by March 4, 2018 and received by March 8, 2018. All methods of entry have the same chance of winning. All entries become the property of the Sponsor and will not be returned.
- 3) PRIZE: LIMIT ONE (1) ENTRY PER PERSON, PER HOUSHOLD, PER E-MAIL ADDRESS.
