

THE JANUARY 2020 WILSON EMAIL COLLECTION A2000 SWEEPSTAKES
(the "Sweepstakes")

OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. ENTRY IN THIS SWEEPSTAKES CONSTITUTES YOUR ACCEPTANCE OF THESE OFFICIAL RULES. EACH PRIZE WINNER IS ONLY ELIGIBLE TO WIN ONE PRIZE IN THE SWEEPSTAKES.

Sponsors: Wilson Sporting Goods Co., a Delaware corporation, with a principal office at 130 E. Randolph Street, Suite 600, Chicago, IL 60601 ("Sponsor").

1. Eligibility:

You must be 18 years or older and a legal resident of any of the 50 United States or the District of Columbia (the "Territory"). Void where prohibited or restricted by law. Void in overseas U.S. territories, possessions, commonwealths and military installations, and where prohibited or restricted by law. Employees, officers, directors, and agents of Wilson Sporting Goods Co. and their affiliates, subsidiaries, advertising and promotional agencies, sponsors, licensees, and any entity involved in the development, production, implementation, administration or fulfillment of the Sweepstakes (all of the foregoing, together with Sponsor, collectively referred to as "Sponsors and Administrators"), and the immediate family members and persons living in the same household as such individuals, are not eligible to participate or win.

2. How To Enter:

(a) The Sweepstakes begins at 8:00:00 AM Central Time ("CT") on Tuesday, January 7 and ends at 11:59:59 PM CT on Tuesday, January 31, 2020 (the "Promotional Period"). Entries must be received by Sponsor by 11:59:59 PM CT on Tuesday, January 31, 2020.

(b) To enter, during the Promotion Period, visit the designated Wilson webpage that was shared via pop-up on Wilson.com. Complete the form for an entry form into the giveaway sweepstakes. The only valid way to enter the Sweepstakes is by completing an entry form on the designated Wilson website. Incomplete or inaccurate entry forms are void. Follow the instructions on the webpage to complete the Sweepstakes entry form, including submitting your name, email address, and other required information. By entering, you acknowledge compliance with these Official Rules including all eligibility requirements.

(c) LIMIT ONE (1) ENTRY PER PERSON, PER EMAIL ADDRESS, OR PER HOUSEHOLD ADDRESS DURING THE PROMOTIONAL PERIOD. LIMIT OF ONE (1) PRIZE PER PERSON FOR THIS PROMOTION. Although subsequent attempts to enter may be received, only the first entry received from a particular individual will be eligible to win. Additional attempts to

enter the same drawing will be disqualified. The submission of an entry is solely the responsibility of the entrant. Entries may only be made according to the method described above. Potential Prize winners will have seven (7) days to respond following notification. In the event a potential Prize winner does not respond within seven (7) days of notification, Sponsor may, in its sole discretion, deem that that potential Prize winner has forfeited his or her Prize, and Sponsor may select another potential Prize winner.
